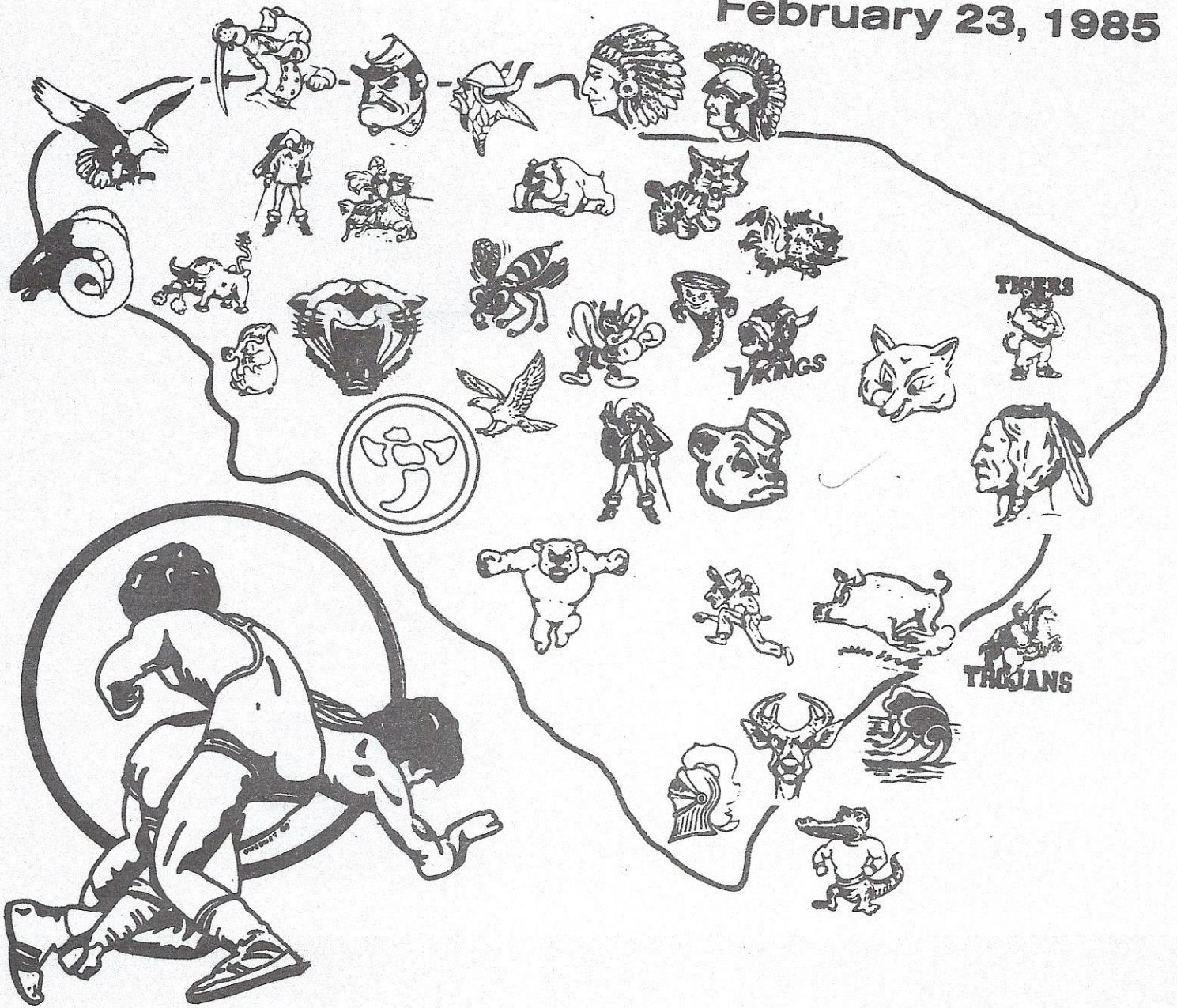

FEES: There is no entry fee. Participating schools will pay 1/2 the cost of every match in which their wrestlers participate or are assigned to and forfeit.

DRESSING AREAS: Dressing areas for all wrestlers will be provided in our Men's Varsity and Physical Education Dressing Areas. All participants are responsible for their own equipment and valuables. Sumter High School will not be responsible for any lost or stolen articles during this tournament.
